*The Affordability Grant is deducted for any child attending the program 50 or more a month. The program receives it based on attended hours, it requires no application. Days missed due to illness or isolation will not be deducted from your hours.

**Subsidy is the second deduction if you qualify for it. It requires you to apply. Maximum subsidy is \$266 per month; the subsidy decreases with the amount of your household income & hours attended. The approved amount you qualify for is deducted from your fees. The program receives the subsidy on your behalf.

Important information

- All fees are by the 1st of the month for the attending month.
- Fees do not change regardless of missed days or holidays within the month.
- For Program closures in December, your monthly fee will be decreased by 25%
- For emergency closures, you will be credited your fee amount of the booked or usual days attending during the closure.
