**DROP-IN FEES**  
 Daily Rate - \$55 (3 hours and over)  
 Hourly Rate - \$9  
 Drop-in days and hours rely on available space; you must communicate with the program a least 24 hours before attendance.

The Affordability Grant is deducted for any child attending the program 50 or more a month. The program receives it based on your child's scheduled hours; it requires no application. Vacation and illness missed days do not affect the grant.

Subsidy requires you to apply. Maximum daycare subsidy is \$266 per month; the subsidy decreases with the amount of your household income (MAX IS \$180,000). The approved amount you qualify for is deducted from your fees. The program receives the subsidy on your behalf.

### Important Information

- All fees are by the 1st of the month for the attending month.
- Fees do not change regardless of missed days or holidays within the month.
- For Program closures in December & April; your monthly fee will be decreased by 25%
- Scheduled Mondays that fall on a holiday may be exchanged for another day in the week where the program has space. The Program Director may approve this change.
